• Water meters must be accessible at all times, and are located in the county right-of-way. Please maintain landscaping to a three- foot radius so the meter is accessible. Failure to maintain landscaping may result in cutting or removal by the Water Department and a fine for obstruction.
• If payment is not received in our office by 15 calendar days past the due date, \$40 will be added to the account and service discontinued.
• Failure to give a termination date in writing will result in customer being responsible for any water usage until account is closed.
• Tampering with meter will result in a fine of \$250.00.
